To improve community mental health by removing barriers, providing education, and linking to services.

Form 990, Part III, Line 2, New Program Services:  
In 2025, MHA of Greater Houston launched a formal Workplace Wellness program to support organizations in creating cultures where people can perform at their best and feel supported. Through customized training and consultation, we equip leaders and teams with practical tools to reduce burnout, improve communication, and strengthen workplace culture. The work goes beyond check-the-box solutions, focusing on lasting change that supports both well-being and organizational success.

Form 990, Part III, Line 3, Changes in Program Services:  
Our Integrated Care Initiative focused on strengthening coordination between mental and physical health providers to support more whole-person care. Due to funding constraints and a strategic shift to prioritize scalable, direct-service programs like Care Connect, the initiative was sunset in 2025. We also made the decision to sunset our Behavioral Health Consultant Certification Course in 2025 due to low participation and limited demand.

Form 990, Part III, Line 4a, Program Service Accomplishments:  
In 2025, we expanded our behavioral health navigation services, now known as Care Connect, a free, coordinated system that helps individuals find, access, and follow through with mental health care. More than a referral service, Care Connect guides people through the process and stays engaged until they are successfully connected to care. The program includes a database of more than 800 vetted providers offering a wide range of services for individuals and families. This resource can be accessed through an easy-to-use online search tool or by connecting directly with a live Community Resource Specialist via phone, text, or email for personalized support. Through peer support and collaborative partnerships, veterans continue to receive the services needed to reintegrate into civilian life. In 2025, working in collaboration with other veteran-serving organizations, a strong 86% of Veterans Treatment Court participants who were eligible for graduation completed the program requirements. Additionally, our veterans team made more than 4,000 referrals, connecting veterans to services that support their well-being and stability.

Our Mental Health Literacy was expanded to offer specialized training to help organizations build cultures where people can perform at their best and feel supported along the way. Our Workplace Wellness training and consultation offerings are guided by a PhD-level expert with certification in mindfulness practices, adapted for organizational settings. In 2025, we delivered 93 mental health education and workplace wellness training sessions, significantly expanding our reach compared to 2024.

Our public policy and advocacy efforts through policymaker engagement increased by more than 188% between 2024 and 2025. We also expanded our

advocacy training, reaching 79 individuals, and increased participation in presentations on MHA-supported issues to 641 individuals.

Our training for child-serving professionals - across schools and community organizations- included 35 presentations supporting adults who work with children. This includes a strong partnership with a statewide intermediary whose mission is to convene, educate, and advocate to improve the quality and increase the availability of out-of-school time opportunities for Texas youth. Through this partnership, we provided training to providers in a variety of programs that support student well-being.

In 2025, 10,160 Greater Houston Region residents used Mental Health America's free, online, and anonymous mental health screenings. These screenings provide a direct, real-time measure of mental health and overall well-being in the Greater Houston Region. Upon completing the screening, each person can access tools and other resources to support their mental health.
